Arch Convergence, Inc is committed to supporting customers with high-quality products and services meeting the directive 2002/95/EC of the European Parliament and of the Council of 27, January 2003 on the restriction of certain hazardous substances (RoHS).

Arch Convergence has undertaken a review of all materials and components used in our products to determine compliance with the RoHS legislation restricting the use of certain hazardous substances.

These substances include the following:

Cadmium, Hexavalent Chromium, Lead, Mercury, Polybrominated Biphenyls and Polybrominated Diphenylesters

We have contacted our suppliers for the raw materials used to produce our products and other than lead; none of the materials named in these directives are knowingly used or intentionally added during the manufacturing process. Please be advised that we do not routinely analyze our products and so trace amounts may be present, giving the potential for low – level contamination.

Further we have analyzed key components of our product using a XFT Hazardous Substance Fluorescence Analyzer. With the exception of lead there is no detectable level of the restricted substances.

Arch Convergence falls under the RoHS exemption of Article 4(I) defined by Annex 1, item 7 that allows for the use of lead in network infrastructure equipment for switching, signaling, transmission, as well as, network management for telecommunications.

All versions of the following products have been evaluated and found to meet the RoHS directive with the lead exemption. More products will be added as evaluated.
